SCOTS TORIES' BREXIT BETRAYAL

"SO what comes first, your loyalty to the captain of a sinking ship or loyalty to the rural communities of Scotland?"

That is what I asked of the Scottish Tories at the European Union Withdrawal Bill, Clause 11 debate last month. Even the Tories know Clause 11 is nothing but a blatant power-grab of devolved competences from the Scottish Government to Westminster that would have absolutely devastating consequences for Scottish farmers, particularly the farmers on the West Coast.



Despite my appeals, the 13 Scots Tories were bought off by a vague promise from the UK Government that they would bring forward their own amendments in order to safeguard the devolution settlement. Needless to say the UK Government's promises were never kept and the amendments didn't materialise, leaving the future of Scotland's devolved parliament post-Brexit to be decided by the unelected House of Lords.

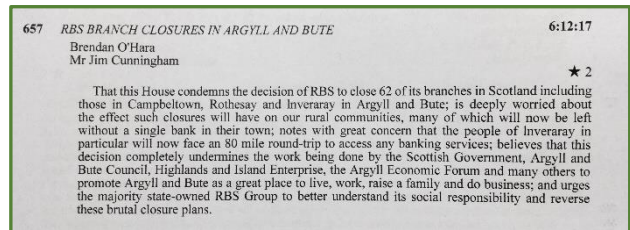
A TRUE WORLD-CLASS DIGITAL NATION

ON THE last day of parliamentary business before the Christmas recess, I was delighted to be able to tell the House of Commons that despite the increasingly hysterical attacks from the Scots Tories and the DCMS, the Scottish Government are well on course to make Scotland a world-class digital nation by 2021. By investing £600 million to provide 30mbps superfast broadband to every home and business, the SNP Scottish Government's ambition outstrips that of any other government in the UK.



PROTECTING ARGYLL & BUTE FROM THE RBS "HATCHET-MEN"

ON WEDNESDAY January 24th, I secured parliamentary time to debate the proposed closure of the, majority state owned Royal Bank of Scotland branches in Campbeltown, Inveraray and Rothesay. Although there



have been a number of debates on the wider issue of branch closures issue, I was absolutely delighted to have time allocated specifically to discuss the closures here in Argyll & Bute and how they will adversely affect, not just the communities involved but the whole of this



constituency. I told the House that these closures will undermine all the good work being done by so many in promoting Argyll & Bute as a great place to live, work, raise a

family and do business. But of course it doesn't have to be this way because the UK Government with a 73% stake in RBS can, if it so wishes intervene to stop these harmful closures. The former Chancellor George Osborne did exactly that when Stephen Hester stepped down as CEO of the bank a few years ago.

as it stands, the UK Government are refusing to accept their responsibility to step in and help, so it's up to us keep the pressure on them. The petitions I launched in Campbeltown,



Inveraray, and Rothesay just before Christmas have been hugely successful and in February I shall present them on the floor of the House of Commons.

TIME TO END THE RURAL RIP-OFF

ONCE again the issue of the disgraceful rip-off of Scottish consumers was highlighted at Westminster. Before the debate I'd asked constituents for their examples, only to be inundated with examples of High Street companies and internet retailers charging extortionate amounts of money to deliver to Argyll & Bute. Thank you to our local SNP councillors, particularly Audrey for helping me to compile a list of examples, some of which I managed to get on the record in the debate.



In one case a delivery company wanted to charge a constituent £90 fee to deliver £18 box of cereal bars to Lochgilhead. Another demanded an extra £300 to deliver a sofa to Dunoon... because Dunoon it seems, is on an ISLAND!! Colleagues from across rural Scotland told similar stories and with the help of the Scottish Government we will continue this fight until this outrage is stopped.

PUPILS TAKE REFUGEE PLEA TO TOWN

I WAS delighted to have been invited to Hermitage Academy in Helensburgh to meet their UNICEF Rights Respecting Group and to help launch their campaign to reunite refugee children with their families. I had no hesitation in offering my support and I urged them not to stop their campaign at the school gate but to talk to their family and friends to change understanding of the issue among people in the town. Hopefully I'll see them at Westminster soon when they deliver their petition to Downing Street.

SSPCA's PUPPY FARMING WARNING

THE growth of illegal puppy farming is something that had been increasingly brought to my attention by constituents. To try and better understand the issue I went to meet Kirsteen Campbell, Chief Executive of the SSPCA as well as the staff and volunteers at their centre in Milton, near



Dumbarton. It also gave me an opportunity to meet the dogs, cats, rabbits, birds, snakes and ferrets currently being cared for at the centre in Milton. What I learned from the SSPCA is that illegal puppy farms and puppy smuggling are growing at an alarming rate and it's now a multi-million pound industry, fuelled by greed and with little or no regard for the welfare of the puppies they sell.

I was delighted therefore to help the SSPCA promote their advice that anyone thinking of buying a puppy exercises great caution and find out exactly where your dog has come from and who it is you are buying your dog from.

WHILE I was in Campbeltown I visited the town's newly-restored Picture House.



And what a job they've done! I was very lucky to
